Krishnapatnam Railway Company Limited (KRCL), is a Joint Venture (a Special Purpose Vehicle) of Rail Vikas Nigam Limited (RVNL), Adani Krishnapatnam Port Ltd., Sagarmala Development Company Ltd., National Mineral Development Corporation Ltd., Government of Andhra Pradesh and Brahmani Industries Ltd. KRCL has constructed the New Electrified B.G. Rail Line of 114 KM from Krishnapatnam station to Obulavaripalle station on South Central Railway (Vijayawada (BZA) Division) providing last mile Rail connectivity to Krishnapatnam Port in Andhra Pradesh.

The Company invites applications from retired Railway officers for appointment for the post of **Advisor** on a Contract Basis for the Company's Corporate Office at New Delhi. Initially, the appointment will be for a period of 1 (One) year, which is extendable for a similar period (upto the age of 65 years), subject to satisfactory performance of the selected candidate and the requirements of the Company.

2. Interested candidates may apply for the post with a recent passport size photograph, detailed bio-data (showing age, education qualifications, experience, last salary drawn as per PPO, achievements) and:

(i) Briefly indicating the number of years of service rendered in Junior/Assistant Scale (JS/AS), Senior Scale (SS), Junior Administrative Grade (JAG), Selection Grade (SG) and Senior Administrative Grade (SAG), indicating the post(s) held/designation, name of Railway, nature of work),

(ii) Duly attaching necessary documents in support of educational qualification, relevant experience/ Service in Railways.

3. Applications for the post are to be submitted by eligible candidates only via email (with all supporting documents) and must be sent to the email address of the company, i.e., <u>krcl.rail@gmail.com</u> latest by 1730 hours of May 15, 2025.

Applications submitted without supporting documents shall be liable for rejection. Applications received after 1730 hours of May 15, 2025 (i.e., completion of 30 days from the date of this vacancy notice) will not be considered.

# 4. Eligibility Criteria for the Post:

- (a) Desired Background: Graduate in any discipline with a total experience of at least 25 (Twenty Five) years in Railways of which at least 5 (Five) years in JAG/SG/ SAG or above. He should have knowledge/experience/exposure in one or more of the following Railway functions: Operations/Commercial/Marketing/ Accounts & Financial Management including Maintenance and Planning of Railway network.
- (b) Age: Not more than 63 years (as on the date of vacancy notice)
- (c) No. of Posts: 01 (one)
- (d) **Educational Qualification (**Minimum**)**: Graduation from a recognized Indian University
- (e) **Computer Working**: Computer Working with user/functional knowledge of MS Office (Word, Excel, PowerPoint, etc.), operating emails, Internet browsing, etc.
- (f) **Remuneration**: 60% of last Basic pay drawn (as per PPO) plus Transport allowance @ 10% of remuneration *or* Staff car;
- (g) **Increment:** Annual increment will be provided as per the Company's policy.
- (h) Location of office: Corporate Office, New Delhi.
- (i) Tenure of appointment: Initially for a period of 1 (one) year on a Contract Basis. Which is extendable for a similar period up to a maximum age of 65 years subject to satisfactory performance of the selected candidate and requirement of services by the Company.
- (j) Job Profile: Dealing with matters relating to Finance, Accounts, Taxation (including GST), Banking, Audit (Internal, Statutory and CAG Auditors), Stores/Inventory, HR, Legal matters, Operations & Commercial, etc. Co-ordination with concerned departments of Indian Railways (Railway Board), viz. Infra Directorate, Traffic Transportation, Traffic Commercial, Accounts, etc., and with all concerned Departments in headquarters of South Central Railway and Divisional office (Vijayawada (BZA) Division). To co-ordinate with RVNL and Railway Board on issues of KRCL, whenever required; to co-ordinate with the Company Rating Agencies and related agencies in the matters of Company Rating. Association of Investors in Railways (AIR) matters: coordinate on matters of mutual/common interest of SPVs. To supervise the preparation of Annual Financial Statements. To supervise and oversee day to day matters/functioning of Corporate Office of KRCL (at New Delhi), etc. Other miscellaneous subjects, as well as any additional responsibilities entrusted by the Managing Director from time to time.

# 5. Criteria of Selection:

- (i) The applications would be scrutinized to ascertain the eligibility and with a view to select for the purpose of interview, only those candidates who are considered suitable in terms of the nature and quality of technical knowledge and professional expertise required for specific post. Applicants meeting the eligibility criteria and found suitable shall be called for interview, details will be intimated through the email indicated along with the application.
- (ii) If the number of applications received are more in number, KRCL reserves the right to shortlist candidates with higher criteria than the minimum eligibility requirements mentioned above.
- (iii) Selection shall be based on the performance in the Interview. Selected candidates will be informed individually at the e-mail address given in the application.

### 6. <u>General Conditions and Instructions:</u>

- (i) Mere submission of application will not entail right to be definitely called for interview/considered further for selection process.
- (ii) Incomplete applications or applications with partial information or non-submission of documents shall be rejected.
- (iii) KRCL reserves the right to cancel/withdraw the Vacancy Notification at any stage without assigning any reason thereof or issuing any further notice.
- (iv) All qualifications should be from Indian Universities or Institutes recognized by UGC/ AICTE/ appropriate Statutory Authorities.
- (v) The cutoff date for determining the age limit, qualification and post qualification experience shall be the date of vacancy notification i.e. 16.04.2025.
- (vi) Only shortlisted applicants will be called for Interview; the details of Interview shall be intimated to shortlisted candidates via E-mail on the E-mail ID provided by the applicants in the application.
- (vii) In case of ambiguity / discrepancy in the information provided by the applicant such application will be summarily rejected.
